Unless you advise otherwise we will also provide you with offers and information related to your Membership which we believe will be of particular relevance and interest to you and may also provide your information to sponsors and/or companies associated with ANZ Stadium for the purpose of providing you with offers and information. **MEMBERS RIGHTS:** The rights and obligations of Gold Members of the ANZ Stadium Club, Stadium Australia Club Limited ABN 52083 753 637 ("the Club") are set out in the constitution of the Club. This document is only intended to set out a general overview of the rights of Gold Members. Gold Members are bound by the constitution of the Club and the rules of the Club. 1. **Gold Members' rights.** 1.1 **Attendance (with no further ticket payment) to:** (a) All sporting events held at the Stadium (other than those events referred to in Sections 1.2 and 1.3) some events to be held in 2018 and the events to be held in the years from 2019 onwards are not yet certain. No representation is made by VenuesLive Management Services (NSW) Pty Ltd as agent for Venues NSW that the events held in the years from 2019 onwards will be similar to those held in 2018. 1.2 **Attendance (with further ticket payment) to:** (a) Major international sporting competitions which VenuesLive Management Services (NSW) Pty Ltd may bid to host, in conjunction with organisations other than the NSW Government or its instrumentalities, such as the Cricket World Cup, Rugby Union World Cup, Football World Cup or any other similar events. (b) All concerts and other non-sporting events held at the Stadium (other than those referred to in Section 1.3 (a) and (c)). 1.3 **Suspension or restriction of rights:** (a) Stadium access for Gold Members and their guests will be suspended or restricted where the Sydney Olympic Park Authority (SOPA), on behalf of the NSW Government, hires the Stadium for major international sporting events such as the Commonwealth Games and international sporting competitions of the type referred to in Section 1.2 (in these circumstances, SOPA has agreed to use its best endeavours, consistent with any undertaking it has given in the obtaining the right to host the relevant event, to negotiate assured seating in the Stadium for Gold Members at full ticket prices). (c) All Gold Members' Stadium access and car park booking rights will be suspended during periods of hire by the NSW Government. 2. **Booking Procedures.** A Gold Member must comply with any booking procedures of the Club in or to attend the events referred to above. 3. **Subscriptions.** Annual subscriptions must be paid by Gold Members by 1 January each year (or within 45 days of the date of invoice, whichever is the later). Subscriptions will be subject to annual increases, being greater of the average increase of public ticket prices to the events held at the Stadium and CPI. The subscriptions will be subject to the review by the Club and VenuesLive Management Services (NSW) Pty Ltd every five years, the next such review being in respect of the subscription payable in 2019. 4. **Time payments.** Failure to make time payments when due may lead, at our sole discretion, to suspension and/or cancellation of your membership with no refund of payments already made at that time. The subscriptions will be subject to the review by the Club and VenuesLive Management Services (NSW) Pty Ltd every five years, the next such review being in respect of the subscription payable in 2019. ## NEW GOLD MEMBERSHIPS 'EASYPAY' MONTHLY PAYMENT PLAN

### TERMS & CONDITIONS

New Gold Membership "EasyPay" Monthly Payment Plan – Terms and Conditions of Purchase

Newly registered Gold Members (or you/your) who have elected the "EasyPay" monthly payment plan option, are authorising VenuesLive Management Services (NSW) Pty Ltd on behalf of Stadium Australia Club Ltd ("Club" or we/us/our) to deduct your one-off Gold Membership joining fee ("EasyPay" Joining Fee) and the first year of your annual Gold Membership Subscription ("EasyPay" First Year Annual Subscription), applicable under the "EasyPay" option, on the terms and conditions set out below. All new Gold Members who provide this authorisation agree to and are bound by these terms and conditions.

- Both the "EasyPay" Joining Fee and the "EasyPay" First Year Annual Subscription will be paid in equal monthly instalments (number of months as per Page 1 of this application), the first payment of which is to be deducted at the date of joining and the remaining payments to be deducted on the first calendar day of each month thereafter. For the avoidance of doubt once a Gold Member has elected the "EasyPay" option, the Gold Member is liable to pay the full "EasyPay" Joining Fee and "EasyPay" First Year Annual Subscription via equal monthly instalments over the period agreed to on Page 1 of this application.
- By selecting the "EasyPay" option and providing us with your relevant credit/debit card details, you are warranting to us that you have the authority to do so and that the information you provide is up-to-date, accurate and complete.
- If we accept the credit/debit card details you provide, you will immediately notify us of any change in details, the expiry date or account holder of the credit/debit card.
- Your Gold Membership will become "Financial" on the date of payment of the first instalment in accordance with clause 1 above, and all privileges, benefits and rights of your Gold Membership will apply. However, please note that Gold Membership runs from 1 January to 31 December each year, and that second and subsequent years' Gold Membership subscriptions will need to be renewed subject to clauses 10 below.
- Should your credit/debit card decline a deduction for a monthly instalment payment, we will contact you to remind you that payment is due.
- Should the monthly instalment remain unpaid 5 business days after the first calendar day of the month, the Gold Membership will become "Unfinancial" and all privileges, benefits or rights conferred on the Gold Member will be suspended, until such time as the monthly instalment(s) is/are paid in full. If necessary, the Club will contact you directly to make alternative payment arrangements (i.e. provide new credit/debit card details).
- A \$10 administration fee will apply to re-instate your membership privileges, at the time that the late monthly instalment payment/s is/are successfully processed.
- Should a Gold Member fail to make an instalment payment when due in any month, and payment has not been received in accordance with clause 6 the balance of the "EasyPay" Joining Fee and "EasyPay" Annual Subscription will become immediately due and payable and will be pursued by the Membership Services department.
- Where an Unfinancial Gold Member, who has elected the "EasyPay" option, has not yet paid all the monthly instalments when due, the Gold Member may have their Gold Membership cancelled by the directors of the Club at their discretion, in accordance with the Club's Constitution.
- Your "Easy Pay" authority will remain in force, unless you provide notice to the Club cancelling your authority. In order to cancel your "EasyPay" authority, the Gold Member must call Member Services. If you cancel your "EasyPay" authority, we will immediately deduct the balance of the "EasyPay" Joining Fee and "EasyPay" First Year Annual Subscription owing to the Club at the date of cancellation.
- Your second year (and subsequent years thereafter) Gold Membership will be subject to the payment of the 'Gold Membership Annual Subscription' invoiced in November for the following year. Gold Members may choose to pay for their subsequent years' Annual Subscription in full or via a 12 month 'EasyPay' option. 12. You must promptly notify us if you believe there is any error in an amount deducted by the Club for a monthly instalment payment. We will investigate the matter and advise you of the outcome.
- You agree that the Club (its officers, employees and agents) are not liable for any errors made by your credit/debit card provider in processing any payments including any loss you incur due to these errors. You agree that our liability to you is limited to refunding to you any amounts wrongly deducted by us. We will request the credit/debit card provider to deduct the correct amount from your account, where the Club is in error.
- Where a Gold Member wishes to transfer their Membership to another person in accordance with the Club's Constitution, the Gold Member will be required to pay the balance of the "EasyPay" Joining Fee and "EasyPay" First Year Annual Subscription, prior to the time of the transfer.
